Editorial

Renovating CES, Transforming the City

Coimbra is traditionally organised between two physical areas, the upper town and downtown, which also define two sociological worlds: the university and the city. This dichotomy continues until today, underlined by invisible barriers, although the medieval walls were demolished and the urban space has become more complex. Research developed at CES has focussed widely on questions associated with this peculiar urban structure, namely with regards to inclusion, gentrification, densification, social justice and ideological attitudes.

For almost three decades now, CES has had its headquarters in the upper town in the spaces of the old hospital emergency ward, with offices, a library and two seminar rooms for a growing community currently comprising 133 researchers, 122 post-doctoral researchers, 468 doctoral students, 61 junior researchers and 25 members of staff. CES' laboratories are not technical ones; they are, instead, the meeting points, the common spaces, the public spaces, the city. This allows us to focus on people, their attitudes, practices, histories and narratives.

Due to its exponential growth, CES has long been looking for more space to create proper conditions for its activity. On one hand, these new spaces should redefine its position in the city map and improve conditions of dialogue with the community at large. On the other hand, the spaces should be designed in such a way as to also improve dialogue within CES' community itself.

Towards these ends, first, CES expanded its spaces in the upper town (Alta), rehabilitating its premises to provide not only offices but also an atrium, a bookshop, a canteen and a balcony, where people can meet around books and food. Secondly, CES extended its position in the city, taking advantage of the renovation of an old college downtown, to be shared with the University of Coimbra's 25 April Documentation Centre. The dormitory of Colégio da Graça has been transformed into offices for research teams, seminar rooms for doctoral courses, a cafeteria for social events and a large corridor for informal activities.

The intervention in the upper town (Alta) will consolidate CES' relation with the university and enhance its infrastructural support to research. The extension to downtown (Baixa) will enable CES to play a major role in the rehabilitation of this abandoned urban area. CES is one of the first institutions to go downtown, after the (de)construction of Rua da Sofia and its university colleges in the 16th century. CES Sofia is an opportunity for the expansion of the research centre, but it also entails a commitment with the city for a more inclusive urban space and a more democratic university.

We imagine the Colégio da Graça courtyard not only as the entrance area to CES, but also as a public space where city and university can meet. This will be duly emphasized on the occasion of the official inauguration, scheduled for April-May 2016.

Is Secularism Bad for Women? – Women, Secularism and Religion



How can societies secure religious women’s freedom and flourishing? What political arrangements offer the most to those who are religious and female? Frequently, the rights of women and reli-

gious people are pitted against each other. Laws, policies and practices are advocated that will help either those of faith, or women, but not both. There is disagreement about the role of religion in the fight for gender equality. Is religion an impediment to gender equality or can it enhance women’s well-being? Some argue that a form of political secularism is the best way to ensure gender equality. Allowing religious organizations political power enshrines gender inequality by giving state support to religious cultural practices that harm women, they say. Reflecting Okin’s 1997 essay ‘Is multiculturalism bad for women?’ they criticize multiculturalism as entrenching gender injustice. Other scholars consider secularism a bad political arrangement for religious people because it excludes them from the political and public sphere. Discovering how states can support equality within and between groups and acknowledge individual and group differences simultaneously is a crucial task. The gender and secularism debate poses challenges to two dominant theories about which political system best promotes the rights of women and religious people. Put simply, feminist scholarship has often neglected religious women (leading to their marginalization), while religious inclusion scholars have neglected women (assuming that religious freedom is available to men and women equally). Policredos, together with the Universities of Uppsala, Coventry, and Helsinki organized a serial of workshops on these topics. The workshops stimulated the creation of a network around the website (<https://womenreligionandsecularism.wordpress.com/>) in which we collect information about conferences, publications and research opportunity and projects on the topics of secularism, women and religion.



Statistical Transparency in the Legal System

Project Hermes was developed to provide more detailed, real time and reliable justice statistics. It aimed at automatically transferring files amongst applications supporting the activities of justice statistics data-producing entities (courts, police, etc.) and the IT Statistical Justice System. This began in the criminal courts from January 2007. However, this new data collection system is far from responding to the goals mentioned above. On the contrary, it has made it more complicated to obtain reliable information and to compare the evolution of both the social and legal demand and the functional performance of the courts. During the first years of operation of this new data collection method, many faults were detected in the indicators produced by the courts, which led to a thorough process of correction. This paralysed the public availability of more detailed statistical data for a long period. The situation got significantly worse after the new legal map was introduced in September 2014, from which originated the well-known crash of the courts’ IT system (CITIUS). The chaos that ensued rendered the majority of the indicators totally unavailable from 2014. The situation remains dependent on “the conclusion of data recovery work and the reinstatement of data provision through Citius,” according to a technical note from Direção Geral de Política da Justiça (Directorate-General for Justice Politics), the entity in charge of managing justice statistics. The importance of accessible statistical data in the legal field is fundamental in three ways: as an instrument for defining public policies, as a fundamental tool to manage the courts, and as a mechanism of transparency for the justice system. Without this information, the courts become more opaque and justice less efficient and transparent.

Telling a story implies not only the creation of a version but also the instilment of meaning to the occurrences that are reported.

Epistemologies of the South: Boaventura de Sousa Santos in Dialogue with ALICE

Epistemologies of the South, a term coined by Boaventura de Sousa Santos, seeks to embody the knowledge and experiences of the global South as a metaphor of exclusion, silencing and destruction of peoples and knowledges. This proposal is underlined by a diversity of places of enunciation in which methodological and reflexive assumptions, in dialogue, oppose proposals of an ethnocentric nature. At the core of Epistemologies of the South is the idea that within the global North looms a sense of intellectual and political exhaustion which translates as a failure to address, in an innovative way, the various challenges the world faces in these early decades of the twenty-first century: social, environmental, inter-generational justice, cultural, historical and cognitive. Contrarily, the global South, in all its diversity, appears today as a broad field of economic, social, cultural and political innovation, a space that aims to increase demodiversity, in which dialogues between knowledges translate into conditions of pluriversity.

Urban sustainable development requires enhancing urban resilience. In this Summer School, we look at resilience as a space for translocal bottom-up learning, and emerging artistic-cultural-ecological approaches as a 'Space of Possibilities'. How far does the potential of such practices reach? When and how do they scale up to wider urban institutions as drivers of transformations, fostering systemic innovations? What limits and challenges do they encounter? How far do they foster a transformative search process of fundamental change, or are they coopted into neoliberal urban development? What recurrent processes and structures can be observed across different contexts? And how can we learn from these in order to support transformative processes? Conceived as an extended workshop, the Summer School will explore comparative insights across different urban initiatives and projects. Insights emerging from the workshop will inform, and be informed by, the ongoing international comparative research project/network "Culturizing Sustainable Cities," and the transdisciplinary research project "The City as Space of Possibility." Critical Economy: Recent Capitalism Evolution in Portugal

The prolonged stagnation and the economic crisis, together with increasing social inequalities that have been aggravated by successive austerity policies created in response to the crisis, demand a rupture from this ideological view and its replacement by a careful analysis of the myriad of mechanisms which help explain the extraordinary weight that finance has acquired.

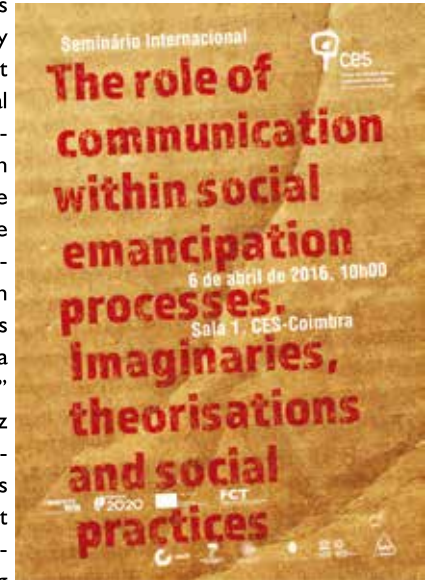

International Seminar

The role of communication within social emancipation processes: Imaginaries, theorisations and social practices

April 6th, 2016, Room 1, CES-Coimbra

Communication Theory has been historically dominated by an “imaginary transmitter” that is grounded on both a colonial perspective and an epistemology of the “North”, which post-colonialist authors like Boaventura Sousa Santos have critically analysed and deconstructed. In this line, and within Communication Theory, it has been mainly the “Latin America communication research line” (e.g., Paulo Freire, Juan Diaz Bordenave, Luis Ramiro Beltra) which, since the 1970s, has subjected western and capitalist ways of understanding communication to criticism, proposing



an approach towards communication which establishes strong relationships with the processes of maintenance and transformation of societies. Within this communication perspective and proposal that emerged from the (epistemological) South, community media became an archetypal example. In the current context of paradigmatic debates in communication theory, where the “epistemologies of the South” play a key role, this seminar will discuss these theoretical and analytical proposals and challenges with researchers and social organizations that provide transformative ideas and practices to rethink communication both at theoretical and practical levels and inform new research and intervention agendas.
