RECRUITMENT OF A PRINCIPAL RESEARCHER IN SOCIAL SCIENCES AND HUMANITIES

The Centre for Social Studies (CES) of the University of Coimbra, Associated Laboratory (LA), opens, by decision of the Board of Directors of May 22, 2024, and for a period of 42 working days, an international competition, within the framework of the Program Contract for Institutional Support - Associated Laboratories, signed with the Foundation for Science and Technology on December 4, 2023, for a position of Principal Researcher, on an open-ended contract, under the terms of paragraph b), no. 1 of article 28 of the Scientific Employment Regulation.

I - REFERENCE, DESCRIPTION OF THE POST, PLACE OF WORK AND REMUNERATION

1. Reference:

2. Scientific Areas:

Social Sciences and Humanities (namely Political Economy, Urban Studies, Social Geography, Development Studies, Political Ecology, Architecture)des.

3. Thematic description of the position:

It is hoped that the candidate will demonstrate, through their previous career and current research interests, a clear affinity with the themes close to the research axes of the Thematic Lines '(Semi)Peripheral Capitalism: Crises and Alternatives' and 'Urban Cultures, Sociabilities and Participation' of the Center for Social Studies (<https://www.ces.uc.pt/pt/ces/linhas>). In particular, affinity will be privileged with areas that articulate the crises of capitalism with the contemporary challenges of territories, such as the political economy of urban space, rentier and financial capitalism and the production of disputed urban space, center-periphery relations in territories,

forms of democratic governance and the right to the city; transformations of the built environment and its historical-cultural landscapes and the role of nature.

4. Work to be carried out:

The researcher selected will carry out their work in the areas of activity defined in the CES Regulations for Hired Researchers:

- research;
- scientific supervision and participation in CES training programs or those with which CES is associated, namely doctoral programs;
- scientific and institutional management;
- outreach, within the scope of CES strategy for the dissemination of research results and the promotion of scientific culture.

5. Place of work:

The work will be carried out at the premises of the Centre for Social Studies, in Coimbra.

6. Nature of the contract and gross monthly salary:

- An open-ended employment contract will be signed, on an exclusive dedication basis, in accordance with the Institutional Support - Associated Laboratories program contract signed with the Foundation for Science and Technology and with the provisions of article 28.1 b) of the Scientific Employment Regulation.
- The gross monthly salary to be awarded is based on the remuneration level of the first step in the category of Principal Researcher, as set out in the Scientific Research Career Statute, approved by Decree-Law no. 124/99, of April 20, as amended by Law no. 157/99, of September 14, and by Decree-Law no. 373/99, of September 18, which corresponds to 3 867,02 euros gross.

7. Legislation and regulations applicable:

The researcher will be hired under the Portuguese Labour Code, approved by Law no. 7/2009, of February 12, in its current wording, and within the framework of the Institutional Support Program Contract - Associated Laboratories, signed with the Foundation for Science and Technology on December 4, 2023, in accordance with the provisions of the Scientific Employment Regulations. The CES Regulations for Hired Researchers also apply.

II - ADMISSION REQUIREMENTS, SELECTION CRITERIA AND EVALUATION PROCESS

8. Admission requirements:

a) The candidate must hold a doctoral degree in a disciplinary area of the Social Sciences or Humanities on the closing date for submission of applications to this competition.

In the event of selection, candidates with an academic degree or diploma issued by a foreign institution must submit proof of recognition of the academic degree in Portugal, under the terms of Decree-Law no. 57/2016, of August 29, amended by Law 57/2017, of July 19, within a maximum of 30 days from the date of communication of the final results, failing which the contract will not be concluded.

b) The candidate must have a significant curriculum vitae in the thematic area of the position, with relevance to the themes that fall within CES's scientific strategy.

c) The candidate must have a minimum of five relevant publications in the last five years, namely articles published in scientific journals with international circulation, chapters or books published by a relevant publisher.

9. Selection criteria and respective weighting:

Candidates will be assessed on the relevance, quality and timeliness of their scientific and curricular background, particularly over the last 5 years, in relation to:

a) Research (50%) b) Teaching, supervision and other training activities (15%)

c) Scientific or institutional management (10%)

d) Extension and dissemination activities (10%)

e) Career Development Plan (15%).

The best ranked candidates in the curricular assessment, up to a maximum of five, will be called to the interview stage, which will consist of a public presentation of the Career Development Plan. The presentation will take place at the CES premises, or exceptionally by remote means, if the candidate lives outside Portugal. The interview/public presentation will have a weighting of 10% in the final grade.

10. Evaluation process

1. Admission of applications: The jury will initially decide on the admission and exclusion of applications in light of the requirements defined in point 8. In the event of non-compliance or partial compliance with the

requirements, the jury will decide whether this insufficiency prevents the application from being considered, or whether it has no relevant impact on the evaluation process, and may still be admitted.

2. Curriculum evaluation (CA): After admitting and excluding the candidates, the jury evaluates the scientific and curricular background of all the candidates admitted, in accordance with the criteria defined in point 9. of this announcement. The selection board should particularly value the merit of the candidate's previous experience in the scientific area or areas for which the competition is open, in accordance with the selection criteria. The evaluation of the scientific and curricular background is carried out in accordance with the criteria and weightings defined in section 9. and is duly substantiated and expressed by the jury on a scale of 0 to 20 points, valued to the hundredths.

The ranking of the candidates results from the classification attributed to each one.

3. Interview (E) / Public presentation of the career development plan: All candidates will be notified by email of their admission or exclusion from the interview/public presentation phase. The presentation will take place in Portuguese or English and will last a maximum of 20 minutes, followed by a question and answer period of up to 40 minutes. The presentation may exceptionally take place remotely, if the candidate requests so, in cases when the candidate lives outside Portugal. The evaluation of the interview will be duly substantiated and expressed by the jury on a scale of 0 to 20, valued to the hundredths.

4. Final classification (FC): The final classification of the candidates will result from the weighted sum of the classifications awarded in each of the phases. After the interviews have been carried out and graded, the selection board will establish the final ranking and order the successful candidates in both methods. The final classification (CF) will be expressed on a scale of 0 to 20, valued to the hundredths, using the following formula:

$$FC = (AC \times 90 \%) + (E \times 10 \%)$$

The Center for Social Studies reserves the right not to hire any candidate if none of the applicants matches the desired profile.

11. Form of publication/notification of results:

All applicants will be notified of the results and the proposed final decision by email. The notification will include the selection minutes signed by the jury and the ranked list of applications.

Candidates may, if they wish, express their opinion on the proposal for final decision at a prior hearing within ten working days from the date of notification of the results.

14. Form of application:

Applications must be formalized by sending:

- Curriculum Vitae, duly dated and signed, in Portuguese or English. The Curriculum Vitae must include an initial page in 'narrative curriculum' format, presenting and justifying the candidate's career, organizing the remaining information in such a way as to respond separately to each of the evaluation criteria and parameters set out in section 9;
- copy of the Doctoral Diploma;
- 5 publications from the last five years that the candidate considers to best represent their main contributions to the advancement of knowledge in the research area, justifying the choice and explaining the specific contribution made in each of these publications when they are co-authored;
- Career Development Plan, relating to the lines of research the candidate proposes to develop, with reference to the CES Thematic Line in which they fall. The Plan (which should be between 3 and 6 pages) must meet the following requirements:
 - Presentation of the main issues to which they intend to devote future research, contextualizing them in the current state of the art in these areas and in their research trajectory;

- Systematized and succinct description of the research strategies that the candidate proposes to adopt in order to develop the research area at CES;
- Contribution to the strategy and objectives of CES, its Risk Observatory and the Thematic Line in which the application falls.

Applications must be sent by email to concursos@ces.uc.pt during the application period, with the subject line “CES/11/2024-CEECInst_PI - NAME OF APPLICANT”.

The application will be considered submitted upon receipt of a confirmation e-mail.

The documents included in the application must be exclusively in digital portable document format (pdf), with the exception of publications, for which you can alternatively, the unique digital identifier (e.g. DOI).

IV - NON-DISCRIMINATION AND EQUAL ACCESS POLICY:
