

POSTDOCTORAL RESEARCHER – 1 (one) vacancy

Call for applications CES/11/2025-PD-TRACE

The Centre for Social Studies (CES) – Associate Laboratory - University of Coimbra (Portugal), opens a call for applications for 1 postdoctoral researcher in the project TRACE – Tracing Queer Citizenship over Time: Ageing, ageism and age-related LGBTI+ politics in Europe – Grant Agreement 101044915, funded by the European Union within the scope of the European Research Council (ERC), and coordinated at CES by Ana Cristina Santos.

CES provides a stimulating intellectual environment in social sciences and humanities. The project is part of Thematic Line 2 "Democracy, Justice and Human Rights" of the Centre for Social Studies.

a. Project Description:

TRACE – Tracing Queer Citizenship over Time: Ageing, ageism and age-related LGBTI+ politics in Europe. In recent years, ageing has been considered a priority area in both governmental policies and research agendas. Sitting at the intersection between Gender and LGBTI Studies, on the one hand, and Age, Ageing and Life Course Studies on the other, and bringing together distant memories and the current daily management of intimate life, TRACE sociologically explores the impacts in later life of growing up in a time when legal recognition was not available for LGBTI+ people. TRACE pays particular attention to issues related to health and well-being, care and intimacy.

Taking queer citizenship as a set of criteria through which democracies can be evaluated, TRACE also explores the extent to which the EU has influenced local political and socio-legal advancements in LGBTI+ rights, narratives and experiences over time. To respond to this aim, TRACE develops an innovative age-sensitive, analytical lens focused on ageing, ageism and age-related LGBTI+ politics through which progress and backlash in countries that experienced substantial changes in their intimate citizenship regimes are investigated. Duration of the project: 48 months, started on January 1, 2023.

b. Scientific field:

Social Sciences and/or Humanities: Gender and/or Feminist Studies.







c. Work plan, tasks:

The selected researcher is expected to have the following responsibilities:

The selected researcher is expected to contribute to the implementation of the project's scientific tasks, as well as to support any activities associated with the project's general goals. More specifically, under the supervision of the PI, the selected researcher will organize and analyse qualitative data in Portuguese and in English, meet stakeholders, conduct interviews, write reports, research papers and/or scientific articles related to the research and other scientific outputs, contribute to the organization of events such as summer schools and conferences organized by the project, and other required dissemination, communication and networking activities; support the PI in tasks that contribute to the objectives of the project. All of these tasks require proficiency in written and spoken Portuguese and English.

d. Applicable Legislation and Regulations:

Labour Code Law No. 7/2009, of February 12th (and subsequent amendments).

e. Work place:

The tasks will be performed at the Centre for Social Studies facilities or in other locations when necessary for the good implementation of the work plan, under the scientific supervision of the Principal Investigator, Ana Cristina Santos.

f. Duration of the contract:

A full-time temporary contract (termo certo) will be signed with the duration of 12 months, renewable in case of scientific need, financial availability, and positive assessment of the work developed. The contract will be foreseeably starting in July, 2025.

g. Application dates:

After June 9, 2025, 23h59 Lisbon time, applications will not be considered for evaluation.

h. Application process:

Applications must include:

- a) a letter of intent/motivation in English with the reference CES/11/2025-PD-TRACE, e-mail and phone number;
- b) detailed Curriculum Vitae in English, highlighting the items most relevant to the topic of the call;
- c) copy of PhD degree certificate and other relevant documents for eligibility purposes (candidates must meet the Mandatory Requirements and conditions indicated in point k.);
 - c1) Applicants need to have a PhD degree by the deadline of this call.

If, for the duration of the application period, the applicant does not have proof of recognition of their academic degree by the Portuguese Higher Education System (law DL66/2018), they must submit a declaration of honour committing themselves to deliver the recognition of the degree within 30 days after the communication of the application results (**Mandatory**).

c2) Documented proficiency in the Portuguese language, unless the candidate is a native speaker of Portuguese.

- d) two relevant publications (indexed journal articles or books chapters) related with TRACE theoretical field and research topics (at least one in English);
- e) other relevant documents for eligibility purposes.

SKILLS/ QUALIFICATIONS

i. Preferred selection criteria and their weighing:

- 1. Adequacy of the CV to the work plan and research objectives (20%);
- 2. Research experience in multidisciplinary teams within the fields of LGBTQI+ issues in Southern Europe, embodied gender diversity and queer ageing, with relevant publications (30%);
- Demonstrated proficient use of BNIM Biographic Narrative Interpretive Method in the past 10 years (30%);
- 4. Demonstrated experience in qualitative analysis of written sources and policy documents (10%);
- 5. Experience in teaching and in outreach activities as well as other dissemination events including documentaries and podcasts related to embodied gender diversity and/or queer ageing (10%).

The jury reserves the right not to select any candidate.

BENEFITS

j. Monthly Allowance

The monthly salary is 2.351,53 euros gross (plus months 13 and 14), equivalent to level 33 of the TRU as set for PhD Early Career Researchers by FCT regulations for Scientific Employment. Daily meal allowance of 6,00 euros/worked day adds up to the gross salary. Full protection by Social Security is included in the contract. Researcher will be covered by Portugal's national health insurance plan, and by an insurance for labour accidents.

ELIGIBILITY CRITERIA

k. Mandatory requirements

- Hold a PhD degree in the area of Gender and/or Feminist Studies (see associated conditions in a) and b);
 - a) Applicants need to have a PhD degree by the deadline of this call.

b) Applicants with an academic degree and diploma issued by a foreign Higher Education Institution must present proof of recognition of the academic degree by the Portuguese Higher Education System,







(law DL66/2018). Any candidate without the recognition of the degree(s) will be admitted to the competition, but during the evaluation process, the selection panel cannot:

i) recognize the candidate's grades and assess according to the possession of such grades; ii) give equivalence to, or validate, the grade of her/his degree; iii) use that note or its conversion as an evaluation parameter.

If, for the duration of the application period, the applicant does not have proof of recognition of their academic degree by the Portuguese Higher Education System (law DL66/2018), they must submit a declaration of honour committing themselves to deliver the recognition of the degree within 30 days after the communication of the application results (**Mandatory declaration of honour**).

In case of selection, the contract can only be signed after recognizing the academic degree by the Portuguese authorities, under the terms of the Law-decree n66/2018, August 16. The selected candidate must deliver the recognition of the degree within 30 days after the communication of the results. After the 30 days, the jury may decide to 1. either extend the deadline for the candidate to prove the recognition; 2. assign the contract to the second place; 3. or not award the contract.

2. Documented proficiency in the Portuguese language, unless the candidate is a native speaker of Portuguese.

SELECTION PROCESS

I. Selection process

Applicants will be selected based on their curricular evaluation. In case of equivalent curricular evaluations, the best-positioned applicants should be short-listed for an interview, meant to assess the applicant's potential in integrating the project's scientific dynamic and the applicant's motivation in pursuing studies related to the project's thematic areas. Each of the two methods of selection applied will have a rating of 50% in the final classification.
