- Europe has got the first priority in Turkey's international Science and Technology Cooperation Policy.
- Turkey is an Associated Candidate Country of the European Union and participated fully in FP6 and now FP7!
- Turkey is a member of major European fora for S&T organizations named EUREKA, COST, ESF, EMBO/EMBC, ESA, INTAS and the like.
- Now Western Balkans wishes to make close RTD cooperation with Europe, also.
- EC has given Special Attention to Balkans under FP6 FP7 specific programmes namely:
 - SEE-ERA.NET and PLUS
 - INCO and SICA and
 - Research Potential
- Now Turkey is interested in cooperating with Balkans by using this European tools and programmes (by contributing the joint pool) and producing new programmes and initiatives nationally.


SEE-ERA.NET (FP6) and PLUS (FP7)

- Scope of the Project: SEE-ERA.NET is a networking project aimed at integrating EU Member States and SEE countries in the ERA by linking research activities within existing national, bilateral and regional RTD programmes
- Countries concerned: 17 Institutions from 14 European Countries WBC + AUSTRIA, Bulgaria, France, Germany, Greece, Hungary, Romania, Slovenia, (Turkey?)
- **Project Budget**: ~1M Euro (Pilot Call). Budget of the calls is from countries. The project is financed by the EC. They have obtained INTAS's electronic submission system.
- **Current Situation:** Turkey is planning to participate in the project and would like to join the next RepSEE call (Regional RTD funding programme for SEE). Steering Committee Meeting would be in Berlin end of March. We expect to clarify the financial contribution of Turkey. They produce see science eu e-journal and TUBITAK is contributing this publication.



• **Activities:** Research projects (ICT, Food, Env.) Networks and Summer Schools. Turkey wants to join SEE-ERA.NET PLUS (FP7)

ISTANBUL AGENDA

- Scope: This agenda is a rolling plan of action to enhance the participation and performance of the enlargement countries under FP7 and further integration in the European Research Area (ERA). The countries engage themselves to this Agenda and count on full cooperation and support of the European Commission.
- Countries: This plan was adopted in Istanbul, on 8 December 2006 with the participation of the following countries: Republic of Albania, Republic of Bosnia-Herzegovina, Republic of Bulgaria (guest-could not attend), Republic of Croatia, Macedonia, Republic of Montenegro, Republic of Romania (guest), Republic of Serbia, Republic of Turkey. The representatives of the SEE-ERA.NET also participated in the meeting.
- Cooperating Areas: Awareness and Information, Increase Participation under FP7, Mobility of Researchers, Involvement of SMEs, Increase Research Capacity.
- Official Application to the EC: TÜBİTAK will send an official cover letter presenting the Istanbul Agenda to the Turkish Ministry of Foreign Affairs, to be sent to the Permanent Mission of Turkey to the EU in Brussels. Then it will be submitted to the EC, also asking for a joint meeting of the representatives of istanbul Agenda partner countries, for the purpose of putting into implementation of the iA.

2215 Ph.D. FELLOWSHIPS FOR FOREIGN COUNTRY CITIZENS

- Travel and research grants in the fields of Natural Sciences, Engineering and Technology, Medical Sciences, Agricultural Sciences, Social Sciences and Humanities (*) will be awarded to highly qualified students who are intending to complete their Ph. D studies in Turkey.
- Acceptance from a Turkish University
- 5 years
- 1.500 YTL. per month

2216 RESEARCH FELLOWSHIPS FOR FOREIGN COUNTRY CITIZENS

- Travel and research grants in the fields of Natural Sciences, Engineering and Technology, Medical Sciences, Agricultural Sciences, Social Sciences and Humanities (*) will be awarded to highly qualified Ph.D. students and young post-doctoral researchers to conduct part of their research in Turkey.
- For Ph. D students; to be enrolled in a Ph.D. programme in a university at abroad.
- For post-doctoral researchers; not to be older than 35 years old.
- 12 months
- 1.500 YTL. per month



Turkish Researchers in SEE (e.g. BIDEB, Hungary, Slovenia opens the national programmes to Turkish Researchers)

Findings and Expectations

- Turkey's national initiatives towards the Balkans are rather new.
- Turkey's inititatives are expected to develop in parallel with the EU Inititaves
- Turkey's programmes are expected to develop while the country develops her S&T base
- Turkey's programmes are expected to develop by providing more money in her GERD and international programmes
- Turkey's participation EU projects will give her a big opportunity to make further cooperation with SEE region and WBC.
- After Istanbul Agenda's implementation Turkey would gain a better role in the area concerned.
- Turkey has to give further attention in implementing social science fellowship programme (MBA. etc.) in a master level as well.
- Turkey needs to take further attention to bilateral projects in WBC as it was happened in the other SEE countries.
